INTENDED USER

dline Dental application tips are developed for professional use in dentistry only. Its user only licensed doctor who has knowledge how to use common dental materials. There is no need for specific training.

dline Dental application tips are delivered non-sterile. There is no need of any preparatory sterilization, cleaning or disinfection, preventive, regular maintenance or calibration to ensure that the device operates properly and safely during its intended lifetime. However, do not use if primary package is damaged.

USE ENVIRONMENT

dline Dental application tips are designed to be used in dental office where ambient temperature is 18-25°C. Do not re-use

CONSUMABLE COMPONENTS AND ACCESSORIES

No consumable components and accessories are supplied with the device.

INSTRUCTION FOR USE

- 1. Twist the application tip into the syringe to lock the tip in place.
- 2. Gently push on plunger and test the flow.
- 3. Perform application on prepared tooth.
- 4. Dispose used application tip as required by national regulatory requirements.

Do not use product for patients who have a history of severe allergic or irritation reactions to product or to any of the ingredients. Product does not emit radiation and does not cause any electromagnetic interferences.

PRECAUTIONS

Wear protective gloves/protective clothing/eye protection/face protection for doctor and patient.

SHELF-LIFE

Shelf-life of disposable micro applicators is 5 years from the date of manufacture. Do not use after the expiry date. See packing for expiry date. Do not re-use.

Keep product tightly closed in dry well-ventilated place at 4-28°C. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Protect from direct sunlight. Dispose of contents/container to as required by national regulatory requirements. Keep out of the reach of children!

DISPOSAL

Dispose of contents/container to as required by national regulatory requirements.
